OLD BUSINESS

1. Installation of 2-hour parking signs and handicap parking spot on Madison Street.

Discussion: Shawn Palmer advises that the work has been completed. Police department is monitoring, educating violators and issuing tickets when appropriate.

2. Request for no parking signs on South Willow Street.

Discussion: Shawn Palmer advises that the work has been completed. Police department is monitoring, educating violators and issuing tickets when appropriate.

3. Traffic patterns outside of Seneca Street Elementary School.

Discussion: Shawn Palmer and Assistant Chief Clark led discussion regarding flashing light equipment. Assistant Chief Clark will draft and send an email to the Oneida City School District (OCS D) to request discussion of cost sharing for equipment and crosswalk improvements. Ongoing maintenance responsibilities should also be addressed if an agreement is reached. Recommendation will be made to OCS D to cone off the area near the crosswalk where "No Parking" signs are posted to increase crosswalk visibility and prevent parking during student drop-off times. The school speed sign near Belmont Avenue was moved after being found blocked by a large tree. Palmer contacted NYSDOT for guidance on school zone signage regulations, and based on their advice, no additional signage changes were deemed necessary. No further action taken at this time.

AGENDA ITEMS

1. Request to install a stop sign on the corner of Summit Avenue and Broadway.
(City Manager Lovell)

Discussion: Kyle Lovell reports being in the area and witnessing several vehicles passing through that intersection, near Allen Park and the Rail Trail. Vehicles were traveling very fast, and neighbors complained about the frequency of occurrence. Request was made to put up a stop sign for eastbound traffic on Summit. Commissioner Jones will complete the work order, and the Police Department will deploy a message board to alert motorists prior to installation.

2. Citizen Complaint – Cycling traffic light at St. Patrick’s School. (Thomas Terrell)

Discussion: Shawn Palmer was aware of this issue prior to the meeting and advised it has already been fixed. The light had been damaged during some roadwork occurring in the area. The repair company has already fixed the light and it’s working normally now. No further action taken at this time.

3. Citizen Complaint – Request to install a speed sign on Cleveland Avenue. (Donna Bonfiglio).

Discussion: The Police Department has placed a speed trailer in the area. This will collect data which will be shared with the Traffic Safety Board prior to the next meeting. Officers are monitoring for violations and conducting enforcement as appropriate. The Traffic Safety Board will send a letter to Ms. Bonfiglio advising her of these measures. The speed limit in the area remains 30 MPH unless otherwise posted.

RESOLVED, to continue monitoring and data collection on Cleveland Avenue and to notify the complainant of ongoing enforcement efforts.

4. Install school zone sign assembly on corner of Seneca/Belmont. (Traffic Advisor Shawn Palmer)

Discussion: Sign had been relocated on October 7th when it was recognized that a large tree was obstructing visibility. Chief Lowell commended Palmer for his efforts and prompt action in addressing the issue. No further action taken at this time.

NEW BUSINESS

1. Speed Signs in Front of Oneida High School

Discussion: Vice-Chairman White asked if speed signs would remain in front of the high school since the school building is not being fully utilized. It was determined that the signs will remain in place due to after-hours events and continuing school-related activities. No formal action taken at this time.

2. E-Bike Enforcement

Discussion: Vice-Chairman White inquired about enforcement of e-bike laws. Chief Lowell reported that amendments to the NYS Vehicle and Traffic Law in 2024 now define e-devices, including e-bikes and scooters. The Police Department hosted state training in early 2025 to educate officers on the changes and has since increased public awareness through social media and community outreach. Special enforcement details have been implemented, and citations are being issued. Chief Lowell noted that funding has been requested for 2026 to support additional targeted enforcement and the purchase of police e-bikes to assist in apprehending violators. No formal action taken at this time.

3. Leonard/Earl Intersection Stop vs. Yield Signs

Discussion: Brian Bortree asked if Leonard/Earl could be considered for stop signs instead of yield signs. After discussion, it was decided to leave the current signage in place and revisit the matter at a later date if needed. No further action taken at this time.

4. 2026 Budget Discussion

Discussion: Chairman Burke asked City Manager Lovell whether any funding was allocated for the Traffic Safety Board in the 2026 budget. Mr. Lovell stated that the City continues to face fiscal constraints and that additional funding will depend on whether the Common Council opts to exceed the tax cap. No further action taken at this time.





Good morning,

After extensive research and an onsite meeting with a gentleman from Madison County Highway, regarding Seneca St. Elementary School. We can do flashing beacons in the locations that the school zone assemblies are placed now. He recommends that we do a double beacon (top & bottom). They have tried solar powered units and have been less than satisfied with the results and have switched to a utility powered option. It is noted that the NYSDOT has recently installed 2 similar solar powered units at RT 46 & Peterboro Rd. These can be seen on Google street view with an address of 6410 West RD. Munnsville, NY. Currently, I am working to confirm the estimated costs. I have got an estimate from an online company for 2 (utility or solar powered) units at a cost of \$11,587.40 + shipping. That cost **does not** include a concrete base, any site work, or electrical supplies.

Hello all,

Just a quick update. With the complexity of this topic, I have reached out to a couple different resources for guidance. I will provide more information when I hear back from them. In the meantime the beacons that are referred to in earlier will not meet the traffic code. The extremely clear reason is found in the MUTCD chapter 4L.01 - Flashing beacons line 03 it states the flash rate. See Below.

CHAPTER 4L. FLASHING BEACONS Section 4L.01 General Design and Operation of Flashing Beacons Support: 01 A Flashing Beacon is a highway traffic signal with one or more signal sections that operates in a flashing mode. It can provide traffic control when used as an intersection control beacon (see Section 4L.02) or it can provide warning when used in other applications (see Sections 4L.03, 4L.04, and 4L.05). Standard: 02 Flashing Beacon units and their mountings shall comply with the provisions of Chapter 4D, except as otherwise provided in this Chapter. 03 Beacons shall be flashed at a rate of not less than 50 or more than 60 times per minute. The illuminated period of each flash shall be a minimum of 1/2 and a maximum of 2/3 of the total cycle. 04 A beacon shall not be included within the border of a sign except for SCHOOL SPEED LIMIT sign beacons (see Sections 4L.04 and 7B.15). Guidance: 05 If used to supplement a warning or regulatory sign, the edge of the beacon signal housing should normally be located no closer than 12 inches outside of the nearest edge of the sign. Option: 06 An automatic dimming device may be used to reduce the brilliance of flashing yellow signal indications during night operation.

Good morning Mr. Carpenter.

I just wanted to give you a follow up response after the traffic safety board met again to discuss the safety concerns with Seneca Elementary.

City Manager Kyle Lovell advised the City could split cost with the school district to get some yellow flashing lights up at the north and south ends of the school. I found some solar powered flashing yellow lights that would work great on Amazon for approximately \$179 each and they would then need some type of a timer added to them so they are only operating during the school zone time frame matching the existing signage.

If an agreement is made and a work order is completed for this, it would have a note on the bottom basically stating the maintenance, and needed replacement if needed would be the responsibility of the school district, not the City.

I have CC'd our Sign department director Shawn Palmer so you can get guidance from him on the legal placement of the lights once some are purchased if we go this route. I have attached links to some I found for you to view and possibly decide which one you would prefer. I feel that this is about the best step we can take to further address the pedestrian and traffic concerns at the school.

Another suggestion was to have someone from Seneca Street elementary place a couple traffic cones stretched a short distance from the crosswalk to keep vehicles from parking too close to it and creating a visual blockage for passing vehicles. This would further ensure that the pedestrians are seen better when crossing and they can easily be placed and removed at the start and end of the school day. Our patrol units have also been directed to check the area more frequently to educate parents on illegal parking when dropping off and picking up children, followed by issuing parking tickets when necessary.

Please just let me know your thoughts on this and I'm sure your maintenance department personnel could figure out a timer addition to these lights as well as a way to mount them on poles at the school. Again, there are many additional options out there, but at a hefty price.

Safety Board for review and recommendation. That ensures we handle the matter consistently with past practice and maintain clear documentation for any future enforcement questions.

Regarding reimbursement, if the Board recommends installation and the City proceeds, the cost of the signs and associated materials should either be covered by the requesting property owner or by an identified City funding source. Since this request addresses an issue specific to a private business, my initial position is that the Owl's Nest should reimburse the Traffic Department for materials unless the Board determines there is a broader public-safety justification for the City to absorb the cost.

Please add this item to the next Traffic Safety Board agenda for formal consideration. Once the Board has weighed in, we can determine next steps regarding installation and cost allocation.
