Following the presentations, Mayor Rossi thanked Commissioner Jones and read a proclamation officially declaring January 6, 2026, as *Dave Jones Day* in the City of Oneida.

### **PROCLAMATION-DAVE JONES DAY**

**WHEREAS**, Dave Jones has served the City of Oneida with distinction as Public Safety Commissioner, providing steady leadership, thoughtful guidance, and objective insight to the Police and Fire Departments; and

**WHEREAS**, his commitment to public service strengthened Oneida's public safety operations and reflected the highest ideals of civic responsibility through his dedication, experience, and professionalism; and

**WHEREAS**, Dave Jones consistently placed the needs of the City first, including his decision to step down at the end of December in recognition of fiscal realities and the importance of responsible governance; and

**WHEREAS**, while no longer serving in an official capacity, Dave Jones remains a strong supporter of the City and a continued advocate for the men and women of the Police and Fire Departments;

**NOW, THEREFORE, BE IT PROCLAIMED**, that I, Rick Rossi, Mayor of the City of Oneida, do hereby proclaim January 6, 2026, as "Dave Jones Day" in the City of Oneida; and

The Mayor requested a moment of silence for Mr. James Chappell, who passed away on December 25, 2025. Deacon Chappell was a former Mayor and Councilor for the City of Oneida and also served as the Fire Department Chaplain.

##### MAYOR ROSSI

The Council then moved on to reports. The Mayor presented his report and expressed optimism about the newly seated Council, noting that with the City's new form of government and the current group of officials, the City is well positioned to move forward.

##### CITY MANAGER LOVELL

During his report, the City Manager stated that this has been the snowiest year on record over the past ten years and expressed appreciation for the DPW plow drivers and crews, including sidewalk and street personnel, for their continued hard work. He noted receiving numerous compliments from residents regarding their performance.

The City Manager also discussed the City's coordination with OCWA to assist neighboring communities, stating that approximately 800,000 gallons of water per day are being supplied to surrounding areas. He confirmed that the City's water system is not under strain and credited infrastructure investments for allowing the system to meet demand. He thanked the Water Department staff for their efforts and coordination and noted the importance of assisting neighboring communities.

Councilor Cimpi encouraged the Council to take a proactive approach, noting that councils often act reactively through approvals of budgets, policies, and legislation. The speaker challenged Council members to return at the next meeting with ideas aimed at improving the City and the lives of its residents.



City Manager Lovell:

City Manager Lovell added that he appreciated the discussion and expressed enthusiasm about working with the newly elected Council members, noting that it had been a long year.

Perception vs reality...that's the challenge isn't it?

Perception vs reality...it's what helps make people, families, and business choose one community over another.

Unfortunately, Oneida has had bad headline, after bad headline, since early in 2024. When at that time, a majority of the Common Council decided to publicly display their disrespect for the citizens of this community, as well various department heads, and other elected officials.

Combined with COORDINATED misinformation campaigns, driven by misguided, partisan, and/or vengeance motivated citizens...and put our community in the news cycle for all the wrong reasons.

When a Syracuse news anchor does the lead into an "on-site" segment by saying, " the mess in the City of Oneida was on full display tonight at the city council meeting"...that's not acceptable.

Every bad story, started with a few of those former councilors, the City codes department at the time, and/or private citizens social media posts.

When every element of that "mess", every "alleged" codes violation, every accusation of " a hostile work environment" is eventually thrown out... by third party outside investigators, or by a judge and DA, determined to be false, without merit or proof...nothing but lies.

Then It is time to hold those responsible for spreading those lies accountable.

Two former codes officers eventually faced consequences, one was fired, another eventually resigned. And well....we have 4 new members of the Council this term.

That misinformation campaign was fueled by hundreds of FOIL requests, and literally thousands of email's, by just 2 or 3 individuals. That misinformation campaign was also fueled by alleged breaches of confidentiality, and ethics violations by members of the Council.

The taxpayers in this City shouldered the cost of that misinformation campaign, not just in the lost productivity of the dedicated employees in City hall who were legally required to respond to those FOIL requests, but in the outside Council legal costs, for those aforementioned third party investigations, and court appearances by Codes.

Now the city has been served with a summons, by the same citizen largely responsible for the majority of those FOIL requests, emails, and misinformation campaign.

That citizen is bringing legal action not only against the City of Oneida, Mayor Rossi, and his wife, but . Madison County, Chenango County, and New York State. That citizen also has two Class A misdemeanor's pending against him, for harassment and Criminal contempt charges. The bench and jury trials for those allegations should be scheduled the first quarter of this year.

"We are free to make our own decisions, but we are not free to control the consequences of those decisions."

And that is why I'm blabbering away in front of you this evening. For that misinformation campaign to end, for the negative press, the negative perception of our City to end...there needs to be consequences for the bad decisions that a few have made.

The Common Council has investigative powers regarding that alleged Ethics violation. A precedent needs to be set, that ethical violations by any city employee, elected, or appointed official's are NOT acceptable.

Likewise, the deliberate spreading of lies, slander, accusations of illegal activities, against city employees, and elected officials, MUST have consequences. Harassing, and/or threatening behavior, slander, defamation of character, and filing false statements, are all subject to legal action.

It's time to make this all stop, and turn this communities focus to the real issues...to positively move our City forward.
