Subject: Professional Engineering Services for the City of Oneida Water Department, April to December 2025, NAAE Proposal No. 6143-B

Dear Mr. Lovell:

Nelson Associates Architectural Engineering (NAAE) is pleased to submit this proposal to provide engineering services for the City of Oneida Water Department. It is our understanding that the City of Oneida desires services for the period April to December, 2025. Work items are summarized below.

A. SCOPE OF SERVICES

The City of Oneida has requested professional engineering services for work in the Water Department. The scope of work was previously outlined in an email from Jeff Rowe, PE dated November 19, 2024 and in a follow-up telephone call held on November 20, 2024. Services were provided in December 2024 and January 2025 and then extended for the period February and March, 2025 with NAAE Proposal #6143-A. This current proposal is for the period April to December, 2025.

The main items of work are listed below.

- > Provide documentation to EPA pertaining to a SDWA request for information.
- Provide updated Water Conservation Program Form and Water Withdrawal Reporting Form.
- > Review existing permits relating to the Water Department for renewal and related reporting.
- Review supporting program documentation for adherence and for required updating.
- Work with current WTP staff to assist in operations review and process decisions as needed.
- > Support current City and Department staff in their efforts to obtain a full-time Water Superintendent.
- > Other tasks as deemed necessary by Oneida Water Department and as agreed to by NAAE.

NAAE intends to assign Andrew Campany, EIT to complete these work items. Andrew will be working under the supervision of Peter Nelson, PE. Mr. Nelson has 41 years of experience as a Professional Engineer. Arthur Smolinski, PE, the NAAE staff currently providing the service, will be available for NAAE staff to consult with as necessary.

In addition to his engineering experience, Andrew Campany, EIT is a Captain in the New York Army National Guard. From 2023 through the present, Captain Campany is serving as the Commanding Officer for the 1156th Engineering Company. This company provides support throughout New York State in operations such as: road repair, grading, bridge repair and structural new builds and remediation. Captain Campany is skilled in providing organizational and logistics leadership, and will bring these skills to the City of Oneida Water Department

NAAE understands work will be delivered primarily from the Water Department offices and also from NAAE office as appropriate for the task. NAAE will provide these services on an hourly basis. Please see attached hourly rates and estimated cost in the Compensation section.

B. PROJECT SCHEDULE

The work under this proposal will be made a priority by the NAAE team and will begin upon written authorization. We anticipate assigning an engineer approximately 2 days per week (16 hours) for the estimated 8-month duration of the project (April to December).

The project schedule can be continued or shortened based upon mutual agreement between City of Oneida and NAAE.

C. COMPENSATION

NAAE will provide the above-described professional services on an Hourly Basis. We anticipate that most hours will be delivered by Andrew Campany, EIT. The hourly rate for an Engineer is \$151. The estimated total amount for the approximate 8-month period is \$99,056. Please see below listed estimate.

D. TERMS OF PAYMENT

An invoice shall be submitted to City of Oneida for the services performed under this contract. City of Oneida shall pay the full amount of the invoice upon receipt. Invoices unpaid in excess of thirty (30) days will be subject to an added interest charge of 1.5 percent per month.

Suspension or Interruption of Services

(Excerpt from AIA Document, Standard Form of Agreement Between Owner and Architect) If the project is suspended or placed on hold by the Owner, the Architect shall be compensated for services performed prior to notice of suspension or interruption, plus lost time related to rescheduling of workload. When the project is resumed, the Architect shall be compensated for expenses incurred in the interruption and resumption of services. The Architect's fee for the remaining services and time schedule shall be equitably adjusted.

E. TIME OF ACCEPTANCE

This offer shall remain firm for a period of thirty (30) days from the date hereof, unless the time for acceptance is extended in writing by NAAE.



§220. Subd. 8

- (a) The head of a state or municipal department, board, commission or office authorized or required by law to issue any permit for or in connection with any work involving the employment of employees in employment as defined in this article, and not withstanding any general or special statute requiring or authorizing the issue of such permits, shall not issue such permit unless proof duly subscribed by an insurance carrier is produced in a form satisfactory to the chair, that the payment of disability benefits and after January first, two thousand and twenty-one, the payment of family leave benefits for all employees has been secured as provided by this article. Nothing herein, however, shall be construed as creating any liability on the part of such state or municipal department, board, commission or office to pay any disability benefits to any such employee if so employed.
- (b) The head of a state or municipal department, board, commission or office authorized or required by law to enter into any contract for or in connection with any work involving the employment of employees in employment as defined in this article and notwithstanding any general or special statute requiring or authorizing any such contract, shall not enter into any such contract unless proof duly subscribed by an insurance carrier is produced in a form satisfactory to the chair, that the payment of disability benefits and after January first, two thousand eighteen, the payment of family leave benefits for all employees has been secured as provided by this article.
