#### **PUBLIC COMMENT**

#### **RALPH KOHLER-ONEIDA**

Comments provided by Ralph Kohler:

I have several questions for the council on the council this evening:

Before I start, I recognize that you are doing a difficult and sometimes thankless job, so let me take a moment to thank you. I know you aren't doing it for the money, but for your view of the good of the community. And that includes both elected and appointed

#### **Budget**

First, last year both Mr. Hedglon and I suggested that we start the budgetary process earlier because in the Russian November last year we saw that there were a bunch of questions that couldn't be answered because of the narrow timelines. Mr. Lovell suggested when I brought this up several months ago that it had started earlier this year. Are we going to delay hearings until November again?

#### **Ethics-Fine**

Second, regarding the ethics investigation, Mr. Lovell said that possible penalties and removal from office and a \$10,000 fine. I asked him where the \$10,000 fine came from because when I look at the law, not being a lawyer and not being an expert in city government, it looks to me like in the current situation the maximum is \$1,000. I sent a note to the city attorney, Ms. Bell to understand the city's position on this but have not heard back. Why do we think the fine is \$10,000, and do you believe there's any chance that any of the elected officials could be removed from office?

# **Emergency Agenda**

Third I think it was particularly bad form to have both of these ethics' agenda items brought up without notice. These are not emergencies, and they certainly should not be treated as such.

## **New Unannounced Items**

My question for tonight- is there anything else new and unannounced that you're going to spring on us, and if so is it an emergency ?

#### **Explanations**

Finally, Mr. Hedglon and the Mayor, at a recent "Meet the Candidates" event, have indicated that going forward they will explain their votes and rationales I would ask all of you to do that this evening and from now on.

## JANET JONES-ONEIDA

Comments provided by Janet Jones:

As we approach budget season, I believe you may have the opportunity to find creative ways to preserve services with more efficient delivery.

When deliberating tonight's Agenda Item #4 to reappoint the city assessor to a 6 year term, I suggest the Council discuss the possibility of creating some efficiencies in the Assessor's Office, given that many of the tasks can and should be automated, and the Charter allows for the Assessor to be employed in other

positions by the City, not incompatible with the office of Assessor.

At a council meeting late last year, it was disclosed that the last assessment was at least 15 years ago, and contracting with an outside firm to handle the processes and communication for reassessment was discussed.

Perhaps the individual that serves as the assessor can also be responsible for some of those chamberlain duties, that meet the city charter compatibility stipulation.

Per the New York State Taxation and Finance website: The assessor is obligated by New York State law to maintain assessments at a uniform percentage of market value each year.

In order to maintain a uniform roll, each year your assessor will need to analyze all of the properties in the municipality to determine which assessments need to be changed.

Every assessment unit should be keeping all assessments at a fair and uniform level every year. Assessors can use computers to efficiently estimate property values. They use computer assisted mass appraisal techniques to analyze sales and estimate values for many properties at once.

## **OLD BUSINESS**

Councilor Hitchings asked Mayor Rossi to speak regarding the ongoing investigation. Mayor Rossi provided an update, stating that the investigation into the breach of confidentiality—authorized by the Common Council at its September 16 meeting—is underway. He noted that the City is in the process of engaging an independent third party to conduct the investigation and deliver findings and recommendations.

# **CITY ASSESSOR REAPPOINMENT-REBECCA LENNON**
