

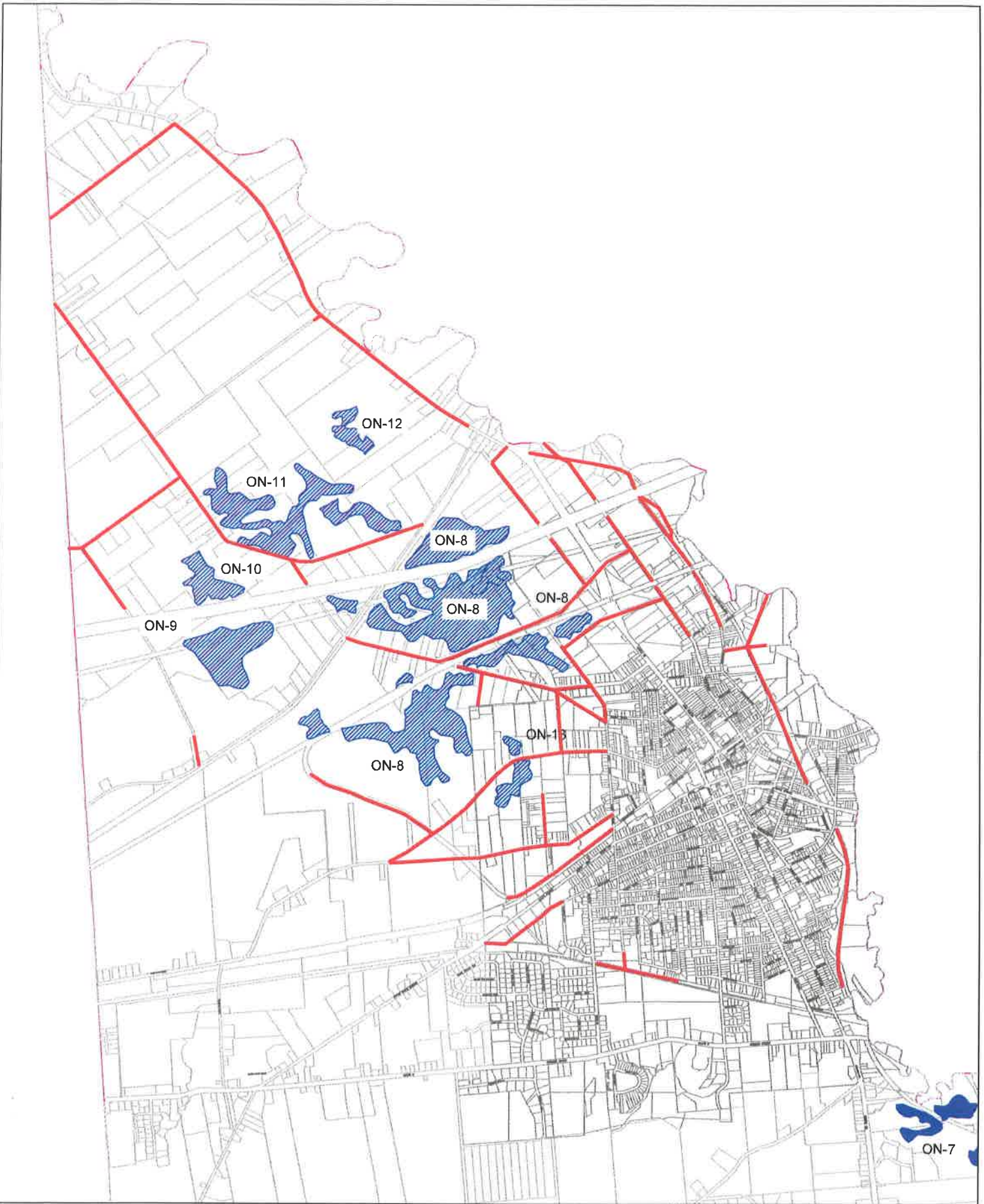
LEGAL NOTICE  
1st Publication

In accordance with Aquatic Pesticide Permit # AI-7-23-44 as issued by the NYS Department of Environmental Conservation (NYSDEC) beginning on or after **July 5, 2023**, the City of Oneida intends to apply a Mosquito Adulticide by a truck mounted ultra-low volume sprayer (ULV) to City streets and access roads for the purpose of controlling adult mosquitos. Kontrol 30-30 (EPA Reg. No. 73748-5) will be used at an application rate of 0.36 ounce per acre. The active ingredient is 30% Permethrin and 30% Piperonyl Butoxide. The US Environmental Protection Agency toxicity category is "Caution". The application will take place between **July 5, 2023 - September 30, 2023**. The target pest is adult mosquitos. The mosquito adulticide spraying will be conducted on Wednesday evenings only, with exceptions to the parks which will be on Monday, Wednesday, and Thursday evenings. A database, as well as map of the locations of streets and parks are on file at the Office of the City Engineer, 109 N. Main Street, Oneida, NY 13421 and are available for viewing during normal business hours, 8:00 AM to 4:00 PM, Monday thru Friday. City of Oneida's Certified Pesticide Applicator, Ernest Leroy, will answer specific questions regarding the proposed pesticide application, to obtain a copy of the pesticide label, or a list of streets that fall in the spray area, can be contacted during normal business hours, 8:00 AM to 3:30PM at telephone number 315-761-6983, alternate, 315-363-7222 Monday thru Friday.
