Call to Order/Pledge of Allegiance/Roll Call

PUBLIC COMMENT

MICHELLE BRACY-6062 Forest Ave., Oneida, NY

Mrs. Bracy advised that she was coming before Council to discuss the hill where she lived at 6062 Forest

Ave. in Oneida. She stated that a City snowplow recently swiped her car on the road in which she lives, noting that it was not done on purpose and that there was nothing that could have been done differently, but that it was because the hill on her road had not been salted properly. She stated that her concern is that someone will get hurt if the road is not properly taken care of and that it puts people at risk for ambulance, fire and police and anyone else who needs to get up and down the hill safely. She stated that they pay taxes, do not have City lights to maintain or sidewalks, and that all she was asking is that the plows salt better for the 5 months out of the year that it is needed.

KATHI BRACY-1581 Crescent Ave., Oneida, NY

Mrs. Bracy concurred with her daughter-in-law, Michelle Bracy, that the road is extremely dangerous 10% of the time and that the road is in terrible condition. She asked that the roads be taken care of the way that they should be.

FRED CIANFROCCO-4484 Seeber Rd., Canastota, NY

Mr. Cianfrocco stated that he was at the meeting to talk about the apartment inspections, noting that he had come to Council before, advising that the City cannot just go into apartments without being welcomed in by either the landlord or the people living there. He also discussed the fee, which he felt they should not have to pay for. He felt this should be covered by the taxes that are paid. He did not feel that the City of Oneida should be compared to the City of Oswego, who has a college, a lake or manufacturing. He questioned what was included in the inspection and questioned the labor involved in performing the inspections.

ROBERT BRITTON-P.O. Box 486, Oneida, NY

Mr. Britton advised that he was not a landlord, but was a citizen/taxpayer who was coming before Council regarding the Code inspection fees. He stated that if the Code Inspection fee is lowered to \$100, with the salary of the inspector per hour and the necessary time for paperwork, wear and tear on the vehicle, etc. they would not break even, noting that the taxpayers should not have to make up the difference on what cannot be made on the inspections.

SHARON/HAL STEVENS-Oneida, NY

Mr. Stevens spoke on behalf of himself and wife Sharon with regard to Code inspection fees, noting that he was not against a reasonable fee, but does not agree with the current fee structure. He mentioned the current inflation rate and that the salaries in the area do not support what the landlords have to pay for the inspections and repairs. He advised that he did not feel the 30-day time frame was reasonable, as they are having difficulty getting supplies and contractors to do the work within that time frame. The Mayor later commented on this, stating that the landlords who were having a problem getting materials and contractors to do the repairs should talk to the Codes Director, Bob Burnett and his group, and they would be able to accommodate for that. She noted that there are always extenuating circumstances and that she understood his concern. She advised that she has apartments as well and is in the same boat.

<u>DISCUSSION:</u> Councilor Reisman inquired if this was done last year in house. City Engineer Rowe advised that the City did some of them with cooperation with the City of Sherrill, who had a stump grinder. They provided the equipment, and the City of Oneida employees did the cleanup. He stated that this was a "Pilot" Program that worked very well. The Mayor advised that they were able to take 13 stumps out in 4 hours, costing only 1.5 gallons of gas. She stated that there are approximately 75 more that need to be removed. The Mayor noted that although this worked well for small stump removal, we still need someone to do the larger stumps, and Big Earl's has the necessary equipment for this.

Councilor Reisman stated that he would like at some point in the future to re-visit the City Manager/Administrator position that had been discussed in the past. The Mayor advised that a Committee should be formed and that the Council could review the old minutes/notes and discuss it at a future meeting.
