#### **PUBLIC COMMENT**

#### JOHN NICHOLS-152 Hunt Valley Rd., Oneida

Mr. Nichols stated that in the interest of transparency, he has concerns about the City Chamberlain's office. He acknowledged that he is aware that the Council cannot give out information about ongoing investigations, especially about a personnel matter, but feels that there should be some answers available to the public. He had questions regarding tax statements, dollar amounts, changes in procedures, audits and the appointment of a position in that department during an election year. He felt that Civil Service procedure was not followed and that more transparency is needed in the City.

#### FRED CIANFROCCO-222 S. Willow St., Oneida

Mr. Cianfrocco reiterated his position from the previous meeting with regard to the increase in rental inspection fees and questioned why the Fire Department could not do the inspections, as opposed to hiring 4 people for the Codes Department. Mr. Cianfrocco feels there should be better communication within the City, noting that transparency is important.

#### **OLD BUSINESS**

Councilor Coulthart asked the Supervisors if there was an update on the Broadband initiative, how as it progresses, we as a City, can take advantage of that. Supervisor Magliocca responded, as he is on the Public Utility Committee that worked on the Broadband initiative. He stated that they had a meeting regarding this last month and anticipated having another in October. He stated that even though Empire Access will eventually be a competitor of Spectrum, they currently are prioritizing extending the backbone fiber to get to the southern portion of the county, noting that there are specific targeted areas that will be done first. He noted that the backbone/highway of the fiber is coming down Route 5 and Route 46. He briefly discussed Empire's long-range business plan, stating that due to the size of this project, they are probably looking at 2025-2026 before this will be done.

Councilor Coulthart also inquired as to where the City is at with regard to the leachate and HP Hood. He asked when we would start seeing action on this. The Mayor advised that she also would like to know that answer and that she put in a call to the attorney earlier in the day to get an update. The Mayor stated that as soon as she gets a response, she will advise Council.

#### PROPOSED LOCAL LAW-PROPERTY TAX CAP LEVY

#### **RESOLUTION 21-145**

Moved by Councilor Earl
Seconded by Councilor Kinville

**RESOLVED,** that a proposed Local Law authorizing a property tax levy in excess of the limit established in General Municipal Law §3-C be hereby received and placed on file as follows:

### Section 1. Legislative Intent

It is the intent of this local law to allow the City of Oneida to adopt a budget for the fiscal year commencing January 1, 2022 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c.

## Section 2. Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

### Section 3. Tax Levy Limit Override

The Common Council of the City of Oneida, County of Madison, is hereby authorized to adopt a budget for the fiscal year commencing January 1, 2022 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-c.

### Section 4. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

### Section 5. Effective date

This local law shall take effect immediately upon filing with the Secretary of State.

**BE IT FURTHER RESOLVED**, that a Public Hearing on the proposed Local Law authorizing a property tax levy in excess of the limit established in General Municipal Law §3-C be scheduled for September 21, 2021 at 6:30 pm.
