Call to Order/Pledge of Allegiance/Roll Call

CEREMONIAL: None

MAYOR'S REPORT

- Mayor Rossi extended a welcome to everyone at the second meeting of the year and announced changes to the meeting format. Moving forward, a Mayor's Report and City Manager's Report will be presented in addition to the Supervisor's Report during the second meeting of each month.
- Mayor Rossi announced that a Local Law concerning Henning will be introduced at the next meeting, with a Public Hearing scheduled for the following meeting.

SUPERVISOR'S REPORT

- Supervisor Matt Roberts noted that there haven't been any committee meetings this year, but Committee assignments have been finalized, and the meetings will start next week. He advised there is a new Chairman, Joseph (John) Pinard, Supervisor for the Town of Lenox, who will be serving a two-year term. Additionally, he mentioned the new Vice-Chair, Melissa During from the Town of Lincoln, who is the first woman to hold this position.
- The 2023 tax receipts (approximately \$42M) have been finalized, and are about 6.5% above last year's, which was \$39M.

CITY MANAGER'S REPORT

- City Manager Selby informed that he has designated Comptroller Lee Ann Wells as City Manager in his absence, as mandated by the new Charter (Section 12.3). He mentioned that a letter would be sent to the Mayor and members of the Council to officially communicate this.
- City Manager Selby advised that he received a Structural Engineer's Report on 136 Madison Street, which was not good. The report indicated that the building needs to be stabilized as soon as possible. DPW has fenced the walls that might be subject to collapse, and they are looking into contractors now for pricing to stabilize this.

OLD BUSINESS

Councilor Rob Winchell raised concerns about the building at 136 Madison St., noting that other property owners are facing challenges accessing their buildings. City Attorney Bell suggested that property owners with concerns should contact the City Manager after the meeting, and a legal solution can be explored to address the issue without putting the City in a position while still safeguarding the property owner. City Manager Selby added that the primary concern was for public safety, avoiding potential injuries for those passing by.
