DRI UPDATES

CITY MANAGER, KYLE LOVELL

At the September 16th meeting of the Common Council, City Manager Kyle Lovell provided updates on Downtown Revitalization Initiative (DRI) projects, noting that the AYSO site visit took place Monday, September 15, and the Vets Field site visit was completed earlier on September 16. The projects are now moving into the 30% design phase, and public comments received by email have been forwarded to the engineering teams for consideration. Lovell said that discussions about the actual drawings should begin within the next couple of months.




Happy Retirement



NEWS FROM ONEIDA CITY SCHOOL DISTRICT

New Policy on Student Use of Internet-Enabled Devices Dear Oneida Families, We want to inform you of a new policy recently adopted by the Oneida City School District regarding the use of **Internet-Enabled Devices** by students during the school day.

Beginning with the 2025–26 school year, students will not be permitted to use Internet-Enabled Devices on school grounds during the instructional day, including during lunch, recess, study halls, and passing times. This includes smartphones, smartwatches, tablets, and other devices capable of internet access.

Why This Change?

This policy supports our commitment to maintaining learning environments that encourage focus, connection, and academic success. Excessive use of devices has been shown to disrupt engagement and student learning.

What Is Still Allowed?

There are specific, limited exceptions, including:

Authorized use for educational purposes during class

Use required for medical needs or as outlined in an IEP/504 Plan

Emergencies or translation needs

Use by a student caregiver under special circumstances

Non-internet-capable cell phones (basic phones)

Device Storage

Students will be required to store their personal Internet-Enabled Devices in lockers or cubbies during the school day.

Enforcement

Violations will be addressed in accordance with the Code of Conduct. However, suspension will not be used as the sole disciplinary action for violating this policy.

Transparency & Reporting

An annual report on the enforcement of this policy will be posted to the District website starting September 1, 2026.

E-BIKES, MOPEDS, SCOOTERS & BICYCLES

At the September 2, 2025 Common Council meeting, a resident raised concerns about unsafe use of electric bicycles (e-bikes). Police Chief Steve Lowell reported that officers have been trained on e-bike operation and applicable laws. Residents are reminded to know and follow all e-bike regulations to protect riders and the community.

ELECTRIC BIKES



Operators must be 16 years old or older!

- E-Bikes are banned on roads with speed limits over 30 mph, sidewalks and public property/land
- Only NYC permits Class 3 E-Bikes, which exceed 25 mph
- E-Bikes do not require DMV registration
- E-Bikes must be ridden as far right as practicable if there is no bike lane and must watch the direction of traffic
- E-Bike differences: Class 1 E-Bikes can travel up to 20 mph; Class 2 and 3 E-Bikes can exceed 25 mph
- Helmets are required for Class 3 E-Bikes

MOPEDS







Class B and C



To legally operate a Moped, drivers must have a valid Driver's License



Class A Mopeds, capable of reaching speeds up to 40 mph, require a valid Class M Driver's License



Both Class B and Class C Mopeds require registration with the DMV



Operating a Class A Moped also nessessitates vehicle registration and a mandatory inspection



Insurance is required for Class A & Class B Mopeds; insurance is recommended for Class C Mopeds



Class B Mopeds can reach speeds of up to 30 mph



Class C Mopeds are limited to 30 mph



Mopeds are considered limited use motorcycles and shall only be ridden in the roadway



Helmets are required for Class A (40 mph) and Class B (30 mph) Mopeds

ELECTRIC SCOOTERS



Operators must be 16 years old or older!

- E-Scooters are for single riders only
- No riding on sidewalks; pedestrians have the right-of-way
- Speed limit is 15 mph; no DMV registration required
- Ages 16-17 must wear a helmet; For adults, helmet use is strongly recommended but not required
- Riding in parks is not allowed
- E-Scooters must be operated on the shoulder or as far right as possible, and must watch the flow of traffic

BICYCLES





Bicycles may not be operated on the sidewalk by anyone over the age of 10



Children ages 14 and under must wear a helmet while operating a bicycle



Bicyclists must operate on the shoulder or as far right on the road as possible, and must match the flow of traffic if there is no bike lane



Bicyclists have the same rights and duties as motorists (rules of the road, stop signs, traffic lights, etc.)



Parents are responsible for their children's safety while operating a bicycle and can be issued a ticket for violations

NEWS FROM NYS

Inflation refund checks The 2025–2026 New York State budget provides for the state's first-ever inflation refund checks. These one-time payments provide relief to New Yorkers who have paid increased sales taxes due to inflation. If you qualify for a payment, you do not need to do anything; we will automatically send you a check. Checks will be mailed over a period of several weeks starting at the end of September 2025. Am I eligible? You are eligible for a refund check if, for tax year 2023, you:

- filed Form IT-201, New York State Resident Income Tax Return;
- reported income within the qualifying thresholds below; and
- were not claimed as a dependent on another taxpayer's return.

How much of a refund will I receive?

The amount of your refund check depends on your income and filing status for the 2023 tax year:



When will I get my check?

We will begin mailing refund checks to eligible taxpayers at the end of September 2025. Over 8 million New Yorkers will receive refunds, and this large volume of checks will be mailed over a multiple week period. You may receive your check sooner or later than your neighbors, as mailings are not based on zip code or region. We **cannot** provide a specific delivery schedule, and our Contact Center representatives will not have additional information on the status of your check.
