

The Codes Department is responsible for evaluating, educating and enforcing local codes. This can be in the form of answering questions, issuing warnings or giving actual citations for code violations. Even though a part of the job does result in violations, code enforcement officers' main objective is to ensure an attractive, lawful and safe community based on Federal law, NYS law, and local laws and ordinances.



# ANNA HOOD CITY CHAMBERLAIN

The main function of the City Chamberlain is the custody of all public funds handled by the City. The Chamberlain collects City and County taxes, water and sewer bills, parking tickets, monthly revenues of various City departments, and assessments. The City Chamberlain is also responsible for accurate records of all taxes on each parcel in the City of Oneida. At the request of abstract companies' attorneys and property owners, the Chamberlain provides a tenyear tax search. This legal document is certified and sealed by the City Chamberlain. At the end of each day, all transactions are totaled, proven, and prepared for deposits into City accounts.



### **WASTE WATER TREATMENT PLANT**

### **ABOUT THE PLANT**

The goal of all wastewater treatment is to change harmful pollutants in waste products into non-polluting products that can be safely released back into the environment. The City of Oneida is responsible for operating the largest wastewater treatment plant (WWTP) in Madison County. The City of Oneida is currently undertaking a multiyear project to implement long-term improvements at the Wastewater Treatment Plant. The new improvements will address the requirements of a NYSDEC Consent Order. In addition, the project includes improvements to the existing aeration basins and secondary clarifiers, solids processing equipment, and organic waste loading processes.



### **PRIMARY**

Primary (mechanical) treatment is designed to remove suspended and floating solids via bar screens and primary clarifiers.

### **SECONDARY**

Secondary (biological) treatment uses an activated sludge process. The process utilizes aerobic microbes to remove dissolved organic matter that escaped primary treatment.

### **EFFLUENT**

From May 15 to October 15 effluent is disinfected using chlorine to kill fecal coliform.


Treated effluent from the WWTP is conveyed to Oneida Creek with a small flow proportion conveyed to the Turning Stone Resort for irrigation use during summer operations. The effluent conveyed to the Turning Stone Resort undergoes additional tertiary treatment. WWTP effluent is regulated by the NYS DEC under a State Pollution Discharge Elimination System (SPDES) permit. The permit mandates water quality parameters and monitoring requirements.

### **PAVING**

### **ROAD DETOUR**

The City's contractor for the Higinbotham Culvert Replacement Project has set up a road detour on Elizabeth St. between East Grove St. and Brooks St. It is estimated that the detour will be in place through August 5.



The Department of Public Works is responsible for improving and maintaining the City's infrastructure. We strive to ensure City infrastructure is safe and well maintained. Our goal is to provide reliable, responsive, cost efficient, and innovative public works services. The department maintains approximately 50 miles of two-lane roads, 40 miles of sanitary sewer, 40 miles for storm sewer, 2,250 traffic signs, 2 earthen dams, and city owned trees. Other responsibilities include scheduled yard waste pickup, pesticide control, tree trimming and removals, street/roadway repairs and resurfacing, mowing of City properties, street sweeper, sanitary/storm sewer cleaning and repairs and maintaining the City's vehicle fleet.

### LEVEL 1 - INTRODUCTION TO WATER SKILLS - AGE: 3 - 4+

- FOR THE BEGINNER WHO IS COMFORTABLE IN THE WATER. MUST BE WILLING TO GO UNDER WATER.
- SWIMMERS LEARN BASICS OF SWIMMING: BOBBING, GOING UNDER WATER, SUPPORTED FRONT AND BACK FLOATING, SUPPORTED ROLLING OVER FROM FRONT TO BACK AND BACK TO FRONT, SUPPORTED GLIDING, SUPPORTED FLUTTER KICK, SUPPORTED FRONT CRAWL ARMS AND JUMPING IN.

#### LEVEL 2 - FUNDAMENTAL AQUATIC SKILLS - AGE: 5+

- SWIMMERS SHOULD ALREADY BE ABLE TO FLOAT ON FRONT AND BACK AND PUT THEIR HEADS UNDER WATER.
- SWIMMERS WILL WORK ON: INDEPENDENT FRONT AND BACK FLOATING, INDEPENDENT ROLLING OVER FROM
  FRONT TO BACK AND BACK TO FRONT, INDEPENDENT FRONT AND BACK GLIDES, FRONT CRAWL ARMS AND
  KICKS, BACK CRAWL ARMS AND KICKS, RETRIEVING UNDERWATER OBJECTS, AND JUMPING INTO WATER OVER
  THEIR HEAD.

#### LEVEL 3 - STROKE DEVELOPMENT - AGE: 5-6+

- SWIMMERS SHOULD ALREADY BE COMFORTABLE SWIMMING FRONT STROKE AND SWIMMING ON THEIR BACK.
- SWIMMERS WILL WORK ON: GLIDING, FREESTYLE WITH SIDE BREATHING, BACKSTROKE, BREAST STROKE AND DOLPHIN KICKS, RETRIEVING OBJECTS IN DEEPER WATER, TREADING WATER, JUMPING INTO DEEP WATER AND COMPACT DIVES.

#### LEVEL 4 - STROKE IMPROVEMENT - AGES: 7-8+

SWIMMERS SHOULD ALREADY BE ABLE TO: SWIM FRONT AND BACK CRAWL 25 YARDS.
 SWIMMERS WILL
WORK ON: ROTARY BREATHING, FREESTYLE, BACKSTROKE, ELEMENTARY BACKSTROKE, SCISSORS KICK AND
SIDESTROKE, WHIP KICK AND BREASTSTROKE, INTRO TO TURNING AT WALL, TREADING WATER WITH
MODIFIED SCISSORS, AND DIVING IN KNEELING POSITION.

#### LEVEL 5 - STROKE REFINEMENT - AGES: 9-10+

 SWIMMERS SHOULD ALREADY BE ABLE TO: SWIM FREESTYLE, BREASTSTROKE AND BACKSTROKE 25 YARDS, SCISSORS KICK, WHIP KICK, TREADING WATER, AND DIVE.
 SWIMMERS WILL WORK ON: ALTERNATE BREATHING, STRIDE JUMP, REFINEMENT OF: FREESTYLE, BACKSTROKE, ELEMENTARY BACKSTROKE, SIDESTROKE, BREASTSTROKE, DOLPHIN KICK AND BUTTERFLY, OPEN TURN ON FRONT AND BACK, FEET-FIRST SURFACE DIVE, AND TREADING WATER.

### LEVEL 6 - SWIMMING & SKILL PROFICIENCY - AGE: 11+

 SWIMMERS SHOULD ALREADY BE ABLE TO: SWIM FRONT AND BACK CRAWL 50 YDS, ELEMENTARY BACKSTROKE 25 YARDS, BREASTSTROKE 25 YARDS, BUTTERFLY 25 YARDS, SIDESTROKE 10 YARDS, TREAD WATER FOR 3 MINUTES, AND DIVE.

SWIMMERS WILL WORK ON: ALL SIX STROKES, FRONT AND BACK CRAWL FLIP TURN, BREASTSTROKE TURN, BREASTSTROKE TURN, BREASTSTROKE SPEED TURN AND PULLOUT, BUTTERFLY TURN, SIDESTROKE TURN, PIKE AND TUCK SURFACE DIVE, PIKE AND TUCK DIVE FROM BOARD, TREAD WATER FOR FIVE MINUTES, AND BASIC WATER RESCUE. PLEASE NOTE: NOT ALL POOLS ARE DEEP ENOUGH TO TEACH ALL OF THE DIVING SEGMENTS OF ALL LEVELS – PROGRAM MODIFICATIONS MAY BE REQUIRED TO MEET SAFETY GUIDELINES.



# ROUND 8-RESTORE COMMUNITIES INITIATIVE



The City of Oneida is spearheading the Madison Street Revitalization Project, as part of the Round 8 Restore New York Communities Initiative grant program. If funded, this project offers a unique opportunity to help revitalize our downtown area by transforming existing structures and vacant land into vibrant mixed-use properties. It will significantly enhance the physical landscape as well as substantially contribute to Oneida's economic vitality.

The proposed rehabilitated and reconstructed buildings will retain the historic character of the originals and be physically connected to one another by a common elevator. Capitalizing on the trending need for practical and creative work-from-home spaces, the redevelopment will include 28 live/work units. Total square footage of the completed areas is estimated at approximately 31,360 square feet.

The Madison Street Revitalization Project aligns with the objectives of the Downtown Revitalization Initiative (DRI) and will continue Oneida's efforts to reinvigorate the downtown central business district. Embracing a more modern, mixed-use model that aligns with the City's Comprehensive Plan, the project is poised to attract businesses, residents, and visitors alike, while driving sustained progress. The dedication and vision of the City of Oneida, coupled with the support of key stakeholders, will pave the way for a brighter, more prosperous future for our entire community.


