

They start at 5pm-Common Council Chambers, and the public is welcome to attend; however, these meetings will not have public comment.

The budget will be received and placed on file November 6th, with the Public Hearing on November 19th. The Council will vote on the adoption of the 2025 Budget at the first meeting in December, which is December 3rd.

# CITY NEWS

## **GLENMORE DAM**

Glenmore Reservoir, on Florence Creek, is the source of water for Oneida. The reservoir, located near Taberg, is approximately twenty miles north of the City. When Glenmore Reservoir was formed in 1926, a 20" pipeline was constructed to convey water to the system of water mains in Oneida that had existed since 1883. This system had earlier been supplied by reservoirs on the south side of the City. In 1980 a water treatment plant was completed at Glenmore with the capacity to supply four million gallons per day of filtered water.

In addition to the City of Oneida, treated water is supplied to the Sherrill-Kenwood District, Durhamville Water District, Prospect Street Water District, the Villages of Wampsville, Oneida Castle, and Vernon, Stockbridge Water District, Taberg Water District, Town of Verona, Skenandoah-Highbridge Water District, and residents along the transmission line.

Glenmore Dam has been in need of repairs for years. The required improvements to the dam include structural stabilization, concrete rehabilitation and repair, the removal of the existing flashboard system, and the existing gunite facing on the downstream face of the dam will be removed and replaced with a concrete overlay with an internal drainage system. This will provide long-term protection to the existing concrete structure, which is deteriorating due to exposure. The dam spillway elevation will be permanently raised to have a safe yield increase of 4 million gallons per day.

City Engineer, Jeff Rowe, advises that there have been recent engineering assessments that have been conducted by consultants that have determined the dam does not have all the required safety features and has a condition rating of 'unsound.' These concerns have been professionally identified by several consultants, and the concern is that if this project doesn't go forward, the Dam could fail — whether it's a catastrophic failure or a partial failure." Should the dam fail, Oneida would not just be left financially responsible for the dam's repair but also for the damage done downstream. Most importantly, a dam failure would jeopardize the City's water supply. The delay in fixing up the Dam was caused by disagreements between the previous governments and the Department of Environmental Conservation. The DEC wanted a guaranteed 200,000 gallons per day of water released downstream during the summer months.

As time goes on, the cost of construction materials increases. Since the first report in 2006, there have been no improvements completed. Rowe said that the original estimate for fixing the Dam was around \$4 million, but now it looks like it will be closer to \$20.56 million. In 2018, the City of Oneida secured an \$8 million bond. However, with the rising costs of construction materials and inflation, approximately another \$12.56 million will be required, bringing the total cost to \$20.56 million.

On October 15, the Council approved to reintroduce a Local Law to address new regulations pertaining to Mobile Food Vendors. There will be a Public Hearing on Wednesday, November 6th at 6:30pm.

Oneida suffered significant damage from the line of thunderstorms that caused the tornadoes on July 16. 
