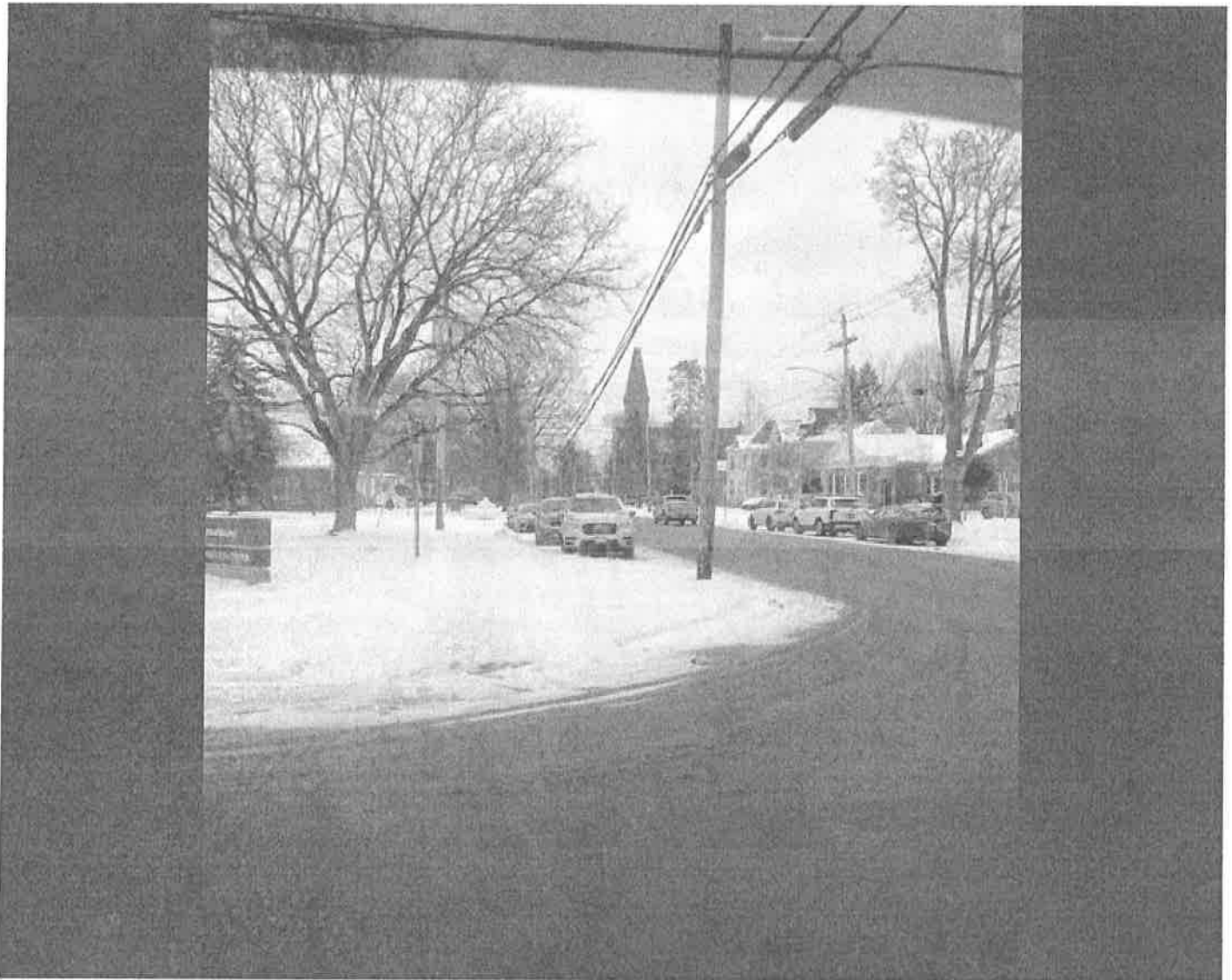

Good afternoon,

I wanted to provide you all with the 2017 TSB minutes regarding this "parking spot" along with a Traffic Order to change the signage to accommodate the food vendor. The spot in question was previously identified as a "No Standing" area with signage to indicate this. It seems; to accommodate the food truck vendor, the city compromised the safety of that area to allow for "seasonal" parking in that spot. We have not followed the traffic order either as signage is supposed to be replaced. I don't think this makes any sense, but all that is irrelevant at this point.

Now that we have new designated spots for the food truck vendors, with ample space, I propose that we once again designate that area as a "No Standing" zone with signage to indicate same.

Good afternoon Chief,

I hope this email finds you well.

I am writing to bring attention to a safety concern regarding the parking spot located on East Railroad Street. This particular parking space facing east, the only one on that side of the street, poses notable hazards to both drivers and pedestrians in the area. As you are aware, this spot was not designated as a "Mobile Food Vendor" spot due to the safety concerns. Now that we have designated it a safety concern for that purpose, it only makes sense that we remove it as a parking spot entirely. A safety concern is a safety concern regardless.

One of the primary issues with this parking spot is that it obstructs the view of traffic for vehicles attempting to navigate the area. The limited visibility creates a hazardous situation, especially for drivers entering or exiting the street. This obstruction increases the likelihood of accidents, as drivers are unable to see approaching vehicles or pedestrians clearly.

In addition to the risk for drivers, the parking spot presents a danger to pedestrians. The restricted line of sight makes it difficult for drivers to notice pedestrians crossing the street, particularly during peak hours. This increases the risk of potential accidents involving pedestrians, which is a serious concern for the community.

Being the only parking spot on that side of the street, it also disrupts the natural flow of traffic. Drivers often need to maneuver around the parked vehicle, which can lead to abrupt lane changes or other unpredictable driving behaviors. This further exacerbates the safety risks for everyone in the vicinity.

To address these concerns, I recommend the following potential solutions:

- Remove the parking spot entirely to ensure unobstructed views and smoother traffic flow.
- Conduct a traffic safety assessment to determine the full extent of the risk and explore alternative parking solutions.

- Consider implementing additional safety measures, such as improved signage or road markings, if the spot remains.

I strongly believe that taking action on this matter will significantly enhance the safety and well-being of both residents and visitors in the area. Thank you for your attention to this pressing issue. I am happy to provide further input or collaborate on potential solutions.

TRAFFIC ORDER

May 22, 2017

Pursuant to the authority vested in me by Article X of Charter of the City of Oneida, New York; I hereby declare, order and establish the following regulation/s regarding traffic control in/at:

N. MAIN STREET / E. RAILROAD ST. INTERSECTION:

- A "No Parking here to corner" sign will replace the existing no standing sign located _____ from Main Street in Clinch Park.
- A temporary "5-Minute parking only" sign will temporarily replace the existing no parking sign located in Clinch Park _____ from Main Street for the season. At the beginning/end of each spring/summer/fall food vendor season, the signs will switch accordingly.
- Two white lines with "No Parking" in the middle of the lines will be painted onto E. Railroad Street in front of the fire hydrant located Clinch Park closest to the Main Street intersection.

This Regulation to become effective upon proper signing.

I have been HORRIFIED to see the speeders and reckless drivers all over within the city of Oneida! I see no law enforcement whatsoever. I have literally been PASSED illegally on BROAD Street for going the speed limit! Apparently no one feels they will get caught and drive like fools.

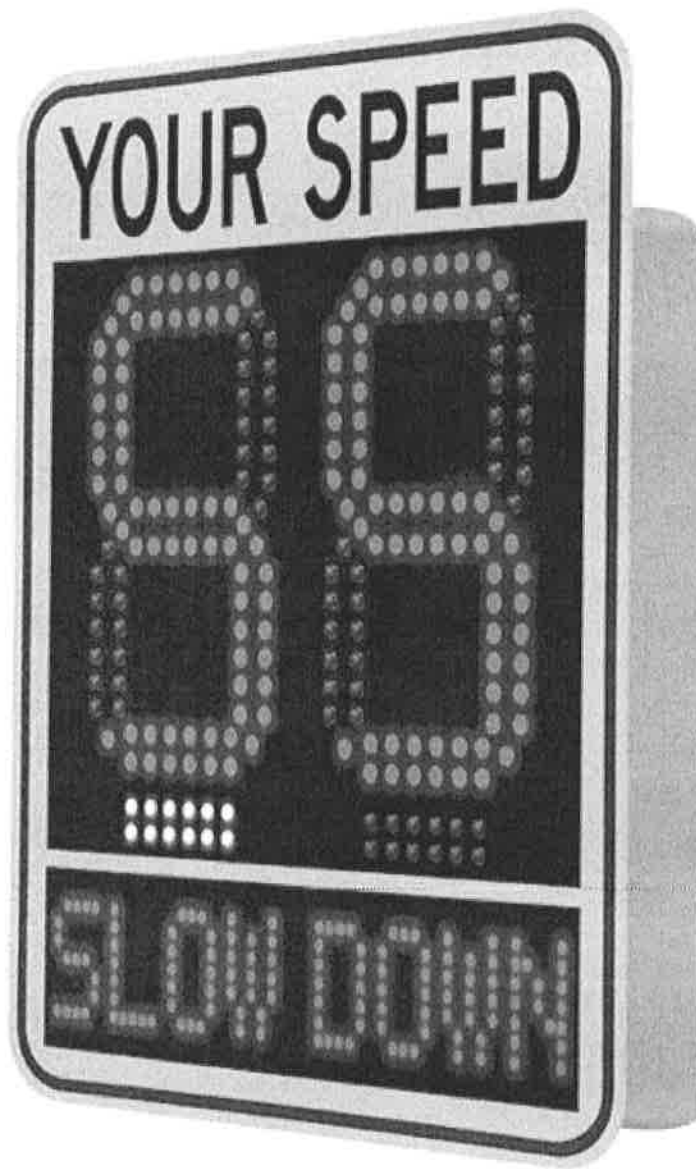
Bates Ave is used as a cut-through from the west side of the city to Broad Street and heavily used, just like Walnut Street. As you are well aware Seneca Street Elementary is right at one end of Bates with many daily walkers in the vicinity.

I called the the police department this past spring/summer and spoke to a sergeant about my frustrations and fears, asking if they could please monitor Bates Avenue. I told him of numerous incidents of speeding vehicles all day and all night (you can hear them gunning their engines from corner to corner) and even a tractor trailer that was not making a delivery on Bates, just passing through -- illegal!

I even suggested they could set up a nice spot on South Ave and see for themselves and raise some revenue for the city! I've never seen any police presence. (I do understand the police department has been understaffed of late and hopefully that will change for the better in the coming year.)

I do believe their presence in the city and their enforcement of speed limits is VITAL for a change and for the safety of all citizens, especially our children and pedestrians.
